Description:

Genomic DNA was extracted from a single culture of *E.coli* using a solution-based method. This DNA is suitable for a variety of applications including genomic library construction, amplification, digestion with restriction endonucleases, and membrane hybridizations (Southern and dot/slot blots).

Quality Control Test:

1. Purified genomic DNA was found to have a molecular weight greater than 50kb as determined by Et-Br stained agarose gel.
2. Purity was determined by spectrophotometry and the ratio of A_{260}/A_{280} is >1.80 .
3. DNA is completely digestible with EcoR1 or Hind III at 37°C.

Note: Do not vortex, mix by gentle pipetting.
