**Description:**

Genomic DNA is isolated from ICR (CD1) mouse colon tissue (individual animal) using solution-based method. This DNA is suitable for a variety of applications including genomic library construction, amplification, digestion with restriction endonucleases, and membrane hybridizations (Southern and dot/slot blots).

**Quality Control Test:**

1. Purified genomic DNA was found to have a molecular weight greater than 50kb as determined by Et-Br stained agarose gel.
2. Purity was determined by spectrophotometry and the ratio of  $A_{260}/A_{280}$  is  $>1.80$ .
3. DNA is completely digestible with EcoR1 or Hind III at 37°C.

**Note:** Do not vortex, mix by gentle pipetting.
