Description:

AMSBIO offers ready-to-use total RNAs from defined tissue types and custom RNA isolation services. The total RNAs are isolated by modified guanidine thiocyanate techniques and stored in RNA storage buffer. Contamination by RNase, genomic DNA polysaccharides and proteoglycans has been effectively eliminated.

Storage conditions: Keep the total RNA at -70°C. Total RNAs are stable for 6 months from the date of receipt, under the correct storage conditions.

Application: The total RNAs are provided ready-to-use for:

- Northern blotting, RT-PCR and RACE
- cDNA synthesis and cDNA library construction
- cDNA probe for profiling study in gene expression
- RNA protection and primer extension
- Purification of mRNA
- MicroRNA study
- RNA differential display.

Quality control:

- The integrity of the RNA is examined by visual inspection for the presence of intact bands of 18s and 28s ribosomal RNA when electrophoreses on a denaturing agarose gel. The quality and purity of total RNA were tested by spectrophotometer. A_{260/280} is between 1.8 and 2.0 (detected in 10 mM Tris-HCl, pH 7.5).
- 2. The RNA is treated by DNAse I, and is tested as DNA free RNA by PCR.
- 3. cDNA synthesis is successfully performed by using this RNA as template.
