**PRODUCTION**Antiserum was solid phase adsorbed to ensure class specificity. The antibody was isolated by affinity chromatography using antigen coupled to agarose beads and conjugated to

horseradish peroxidase (HRP).

Prior to conjugation, immunoglobulin concentration was determined using Beer's Law where

1mg/mL lgG has an A280 of 1.4. Molar enzyme/antibody protein ratio is 4:1.

By immunoelectrophoresis and ELISA this antibody reacts specifically with rat IgM. This

antibody may cross react with IgM from other species.

**APPLICATIONS** Centrifuge tube to remove product from lid. Optimal working dilutions should be determined

experimentally by the investigator. Prepare working dilution immediately before use.
