Immunogen was a peptide representing a region between residue 1205 and the C-terminus (residue 1255) of human receptor tyrosine-protein kinase ErbB-2 (aka HER2) using the numbering given in entry NP_004439.2 (Gene ID 2064).
<b>APPLICATIONS</b>	Centrifuge tube to remove product from lid. Optimal working dilutions should be determined experimentally by the investigator. Prepare working dilution immediately before use.  A700-241CF is the carrier-free version of A700-241, which is qualified for use in Western Blot, Immunoprecipitation, Immunohistochemistry, and/or Immunocytochemistry. The format of A700-241CF is designed for compatibility with the labeling of the antibody such as with fluorochromes, metal isotopes, oligonucleotides, and enzymes. Upon completion of labeling, the user must empirically define the assay dependent concentration for use.
