Laboratory Procedures

Leukotriene C₄-d₅ (LTC₄-d₅) contains five deuterium atoms at the 19, 19', 20, 20 and 20 positions. It is intended for use as an internal standard for the quantification of LTC4 by GC- or LC-mass spectrometry (MS). For long term storage, we suggest that LTC₄-d₅ be stored as supplied at -80°C. It will be stable for at least one year.

 LTC_4 -d₅ is supplied as a solution in ethanol:water (95:5). To change the solvent, simply evaporate the ethanol:water under a gentle stream of nitrogen and immediately add the solvent of choice. Solvents such as DMSO and dimethyl formamide purged with an inert gas can be used. The solubility of LTC₄-d₅ in these solvents is approximately 50 mg/ml.

LTC₄-d₅ is used as an internal standard for the quantification of LTC₄ by stable isotope dilution MS. The accuracy of the sample weight in this vial is between 5% over and 2% under the amount shown on the vial. If better precision is required, the deuterated standard should be quantitated against a more precisely weighed unlabeled standard by constructing a standard curve of peak intensity ratios (deuterated versus unlabeled).

LTC₄ is the parent cysteinyl leukotriene produced by the addition of glutathione to LTA₄. LTC₄ is produced by neutrophils, macrophages, and mast cells, and by trans-cellular metabolism in platelets. It is one of the constituents of slow-reacting substance of anaphylaxis (SRS-A) and exhibits potent smooth muscle contracting activity.² LTC₄-induced bronchoconstriction and enhanced vascular permeability contribute to the pathogenesis of asthma and acute allergic hypersensitivity.^{3,4} The concentration of LTC $_4$ required to produce marked contractions of lung parenchymal strips and isolated tracheal rings is about 1 nM.4
