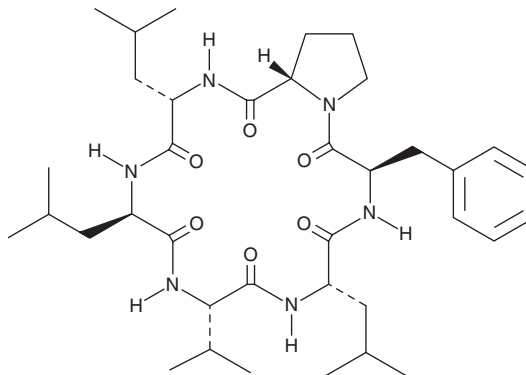

Laboratory Procedures

Phepropeptin A is supplied as a powder. A stock solution may be made by dissolving the phepropeptin A in the solvent of choice, which should be purged with an inert gas. Phepropeptin A is soluble in methanol, DMSO, and dimethyl formamide.

Description

Phepropeptin A is a cyclic peptide originally isolated from *Streptomyces* that has proteasome inhibitory activity.¹ It inhibits isolated mouse liver proteasomes ($IC_{50} = 21 \mu\text{g/ml}$).
