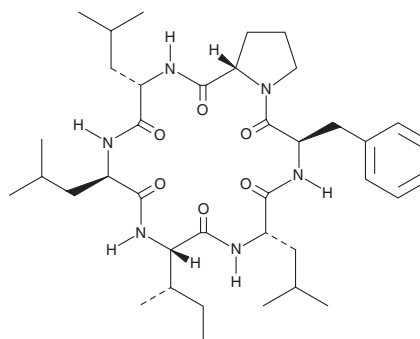

Laboratory Procedures

Phepropeptin C is supplied as a powder. A stock solution may be made by dissolving the phepropeptin C in the solvent of choice, which should be purged with an inert gas. Phepropeptin C is soluble in methanol, DMSO, and dimethyl formamide.

Description

Phepropeptin C is a cyclic peptide originally isolated from *Streptomyces* that has proteasome inhibition activity.¹ It inhibits isolated mouse liver proteasomes (IC₅₀ = 12.5 μ g/ml).
