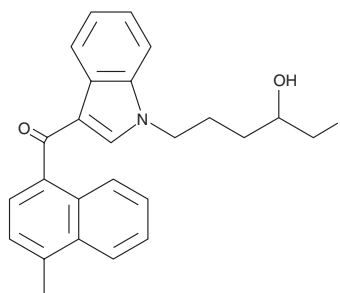

MAM2201 N-(4-hydroxypentyl) metabolite is a potential phase 1 metabolite of MAM2201, based on the known metabolism of similar compounds. The physiological properties of this compound have not been evaluated. This product is intended for forensic and research applications.
