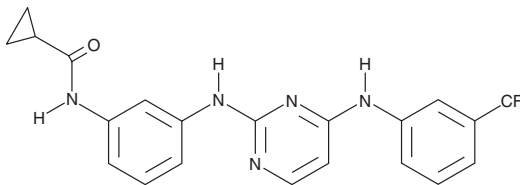

Laboratory Procedures

Aurora kinase inhibitor III is supplied as a solid. A stock solution may be made by dissolving the aurora kinase inhibitor III in the solvent of choice. Aurora kinase inhibitor III is soluble in organic solvents such as DMSO and ethanol, which should be purged with an inert gas, at a concentration of approximately 20 and 50 mg/ml, respectively.

Description

Aurora kinase inhibitor III is a potent inhibitor of Aurora A kinase ($IC_{50} = 42$ nM).¹ It is selective for Aurora A over BMX, BTK, IGF-1R, c-Src, TRKB, SYK, and EGFR (IC_{50} s = 386, 3,550, 591, 1,980, 2,510, 887, and >10,000 nM, respectively).
