

Laboratory Procedures

Rofecoxib-d₅ is intended for use as an internal standard for the quantification of rofecoxib (Item No. 10010260) by GC- or LC-MS. The accuracy of the sample weight in this vial is between 5% over and 2% under the amount shown on the vial. If better precision is required, the deuterated standard should be quantitated against a more precisely weighed unlabeled standard by constructing a standard curve of peak intensity ratios (deuterated versus unlabeled).

Rofecoxib- d_{ϵ} is supplied as a solid. A stock solution may be made by dissolving the rofecoxib- d_{ϵ} in the solvent of choice, which should be purged with an inert gas. Rofecoxib- d_{ς} is soluble in organic solvents such as DMSO and acetonitrile.

Description

Rofecoxib is a non-steroidal anti-inflammatory drug (NSAID) that selectively inhibits COX-2 over COX-1 with IC $_{50}$ values of 0.018 and >15 μ M, respectively, for production of prostaglandin E $_{2}$ (PGE₂; Item No. 14010) in CHO cells expressing the recombinant human enzymes. In vivo, rofecoxib inhibits carrageenan-induced paw edema and hyperalgesia (ID₅₀s = 1.5 and 1.0 mg/kg, respectively), LPS-induced pyresis ($ID_{50} = 0.24 \text{ mg/kg}$), and M. butyricum-induced arthritis ($ID_{50} = 0.74 \text{ mg/kg}$ per day) in rats. Formulations containing rofecoxib were previously used in the treatment of pain and arthritis.
