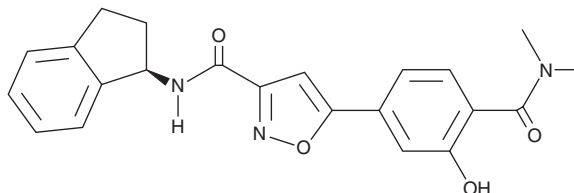

Laboratory Procedures

PFI-6 is supplied as a solid. A stock solution may be made by dissolving the PFI-6 in the solvent of choice, which should be purged with an inert gas. PFI-6 is slightly soluble (0.1-1 mg/ml) in acetonitrile and methanol, and sparingly soluble (1-10 mg/ml) in DMSO.

Description

PFI-6 is a chemical probe for the YEATS domain-containing proteins MLLT1 and MLLT3 (IC₅₀s = 140 and 160 nM, respectively).¹ It is selective for MLLT1 and MLLT3 over YEATS domain-containing 2 (YEATS2) and YEATS4 (IC₅₀s = >30,000 nM for both).
