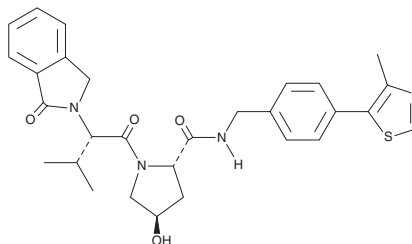

Laboratory Procedures

VL285 is supplied as a solid. A stock solution may be made by dissolving the VL285 in the solvent of choice, which should be purged with an inert gas. VL285 is soluble (≥10 mg/ml) in DMSO. VL285 is sparingly soluble (1-10 mg/ml) in ethanol.

Description

VL285 is a starting material that has been used in the synthesis of proteolysis-targeting chimeras (PROTACs) that drive the degradation of tagged proteins.¹
