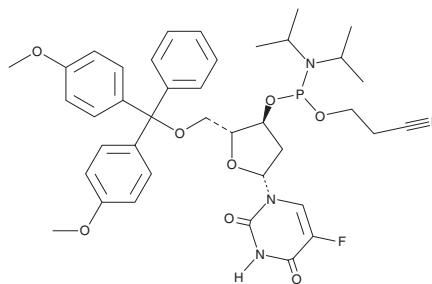

Laboratory Procedures

5'-DMT-5-F-2'-dU phosphoramidite is supplied as a solid. A stock solution may be made by dissolving the 5'-DMT-5-F-2'-dU phosphoramidite in the solvent of choice, which should be purged with an inert gas. 5'-DMT-5-F-2'-dU phosphoramidite is sparingly soluble (1-10 mg/ml) in ethanol and DMSO.

Description

5'-DMT-5-F-2'-dU phosphoramidite is a nucleoside building block that contains 5-fluorouracil (Item No. 14416) and has been used in the synthesis of DNA strand-based polyhedral nanoparticles for use as anticancer agents *in vivo*.¹
