0.2 µg of Human CDH17, His tagged protein per well

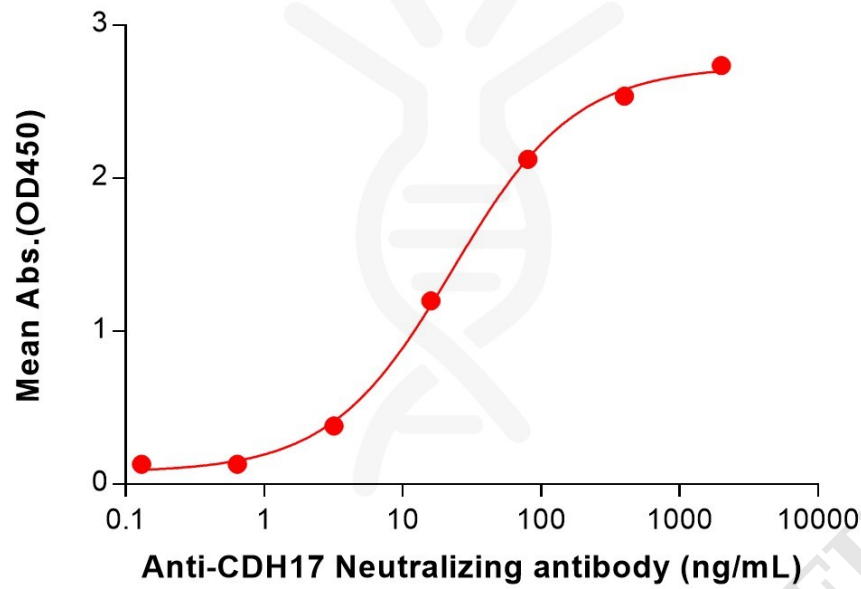


Figure 1. ELISA plate pre-coated by 2 µg/mL (100 µL/well) Human CDH17 Protein, His Tag (PME100801) can bind Anti-CDH17(TORL-3-600 biosimilar) mAb (BME100233) in a linear range of 3.20-400 ng/mL.

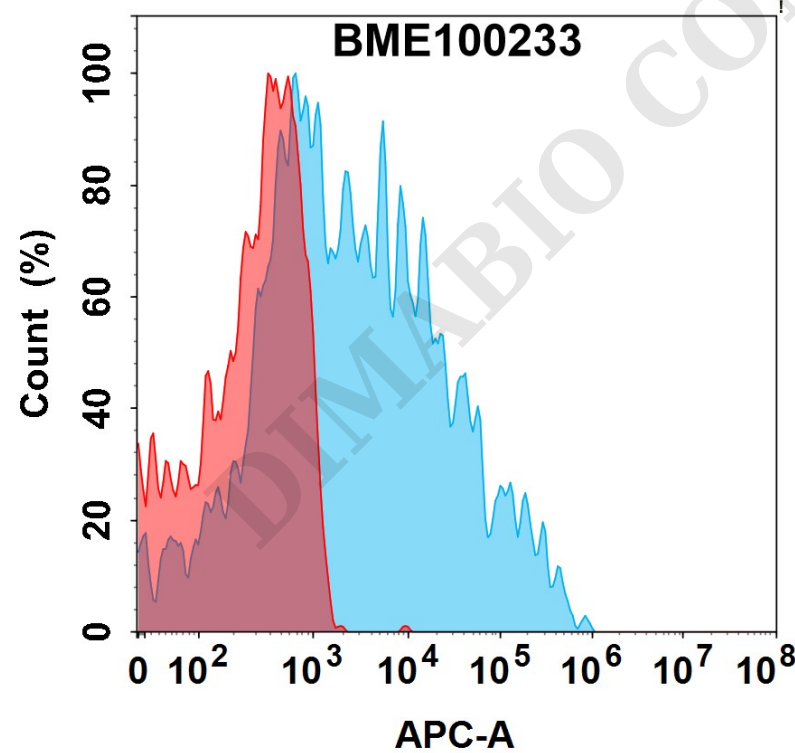


Figure 2. Flow cytometry analysis with 1µg/mL Anti-CDH17(TORL-3-600 biosimilar) mAb (BME100233) on Expi293 cells transfected with Human CDH17 protein (Blue histogram) or Expi293 transfected with irrelevant protein (Red histogram).
