Background:	Resistin-Like Molecule-beta (RELM- β) is a member of a recently identified family of secreted proteins containing conserved cysteines in their C terminus. The RELM family consists of Resistin (also called FIZZ3), RELM-α (FIZZ1), and RELM-γ. Only Resistin and RELM-β have been identified in humans whereas all four RELM family members have been identified in rodents. Recombinant mouse RELM-β is a non-glycosylated protein, containing 83 amino acids, with a molecular weight of 8.9 kDa.

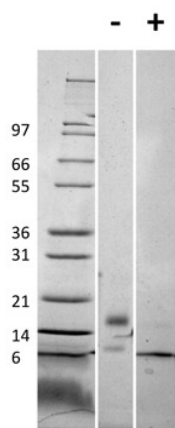

Storage Condition:	Store vial at 4° C prior to restoration. Dilute only prior to immediate use. Maintain sterility. This product DOES NOT contain preservative. DO NOT VORTEX. We recommend adding a carrier protein such as HSA or BSA to 0.1% (i.e. 1.0 mg/mL). For best results aliquot contents and freeze at -20° C or colder. Avoid cycles of freezing and thawing. Centrifuge vial before each opening to dislodge contents from the cap and to clarify if contents are not clear after standing at room temperature.
Expiration:	Expiration date is six (6) months from date of receipt.

SDS-PAGE of Mouse RELM beta Recombinant Protein. Lane 1: Molecular weight marker. Lane 2: 1 μ g Mouse Relm beta in non-reducing conditions (-). Lane 3: 1 μ g Mouse Relm beta in reducing conditions (+). Mouse Relm beta is a predicted homodimer with a predicted MW of 18 kDa.
