	that bind horse IgG F(c) will not bind horse IgG F(ab')2 molecules. Secondary Antibodies are

	product, consideration must be given to species and immunoglobulin specificity, conjugate type,

Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-rabbit serum, Horse IgG, Horse IgG F(ab')2 and Horse Serum. No reaction was observed against Horse IgG F
