Assay by immunoelectrophoresis resulted in a single precipitin arc against<br/>anti-Peroxidase, anti-Rabbit Serum, Bovine IgG and Bovine Serum.

#### **Application Details**

A working dilution of 1:17,000 to 1:70,000 of the reconstitution concentration is suggested for this product.

Storage Condition:	Store vial at 4° C prior to restoration. For extended storage aliquot contents and freeze at -20° C or below. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use.
