<b>Background:</b>	Anti-Human IgM (mu heavy chain) Peroxidase generated in rabbit detects specifically Human IgM mu heavy chain. Immunoglobulin M is the largest antibody isotype and the first to be secreted against an initial exposure to antigen. IgM is predominantly produced in the spleen. Formed from covalently linking 5 immunoglobulins together. Anti-Human IgM mu chain antibody is ideal for investigators in Immunology, Microbiology, and Cell Biology.

<b>Purity/Specificity:</b>	This product is an IgG fraction antibody purified from monospecific antiserum by a multi-step process which includes delipidation, salt fractionation and ion exchange chromatography followed by cross adsorption and extensive dialysis against the buffer stated above. Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Peroxidase, anti-Rabbit Serum, Human IgM and Human Serum. No reaction was observed against Human IgG.

## Application Details

<b>Application Note:</b>	Anti-Human IgM (mu heavy chain) Peroxidase has been assayed against 1.0 ug of Human IgM in a standard capture ELISA using ABTS (2,2'-azino-bis-[3-ethylbenthiazoline-6-sulfonic acid]) code # ABTS-100 as a substrate for 30 minutes at room temperature. A working dilution of 1:1,000 to 1:3,000 of the reconstitution concentration is suggested for this product.
<b>Assay Dilutions:</b>	All assays should be optimized by the user. Recommended dilutions (if any) may be listed below.
<b>ELISA:</b>	1:10,000 - 1:50,000
<b>IHC:</b>	1:500 - 1:2,500

<b>Stabilizer:</b>	10 mg/mL Bovine Serum Albumin (BSA) - Immunoglobulin and Protease free

<b>Reconstitution Buffer:</b>	Restore with deionized water (or equivalent)

<b>Shipping Condition:</b>	Ambient
<b>Storage Condition:</b>	Store vial at 4° C prior to restoration. For extended storage aliquot contents and freeze at -20° C or below. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use.
<b>Expiration:</b>	Expiration date is one (1) year from date of receipt.
