Background:	F(ab')2 Anti-Goat IgG F(ab')2 Peroxidase Antibody generated in rabbit detects Goat F(ab')2. Representing approximately 75% of serum immunoglobulins, IgG is the most abundant antibody isotype found in the circulation. IgG molecules are synthesized and secreted by plasma B cells. Secondary Antibodies are available in a variety of formats and conjugate types. When choosing a secondary antibody product, consideration must be given to species and immunoglobulin specificity, conjugate type, fragment and chain specificity, level of cross-reactivity, and host- species source and fragment composition. F(ab')2 Antibody is ideal for investigators who routinely perform flow cytometry, immunohistochemistry or IHC and other immunoassays.

Purity/Specificity:This product is a F(ab')2 fragment of an IgG fraction antibody purified from monospecific
antiserum by a multi-step process which includes delipidation, salt fractionation, ion exchange
chromatography and pepsin digestion followed by extensive dialysis against the buffer stated
above. Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-
Peroxidase, anti-Rabbit Serum, Goat IgG F(ab')2 and Goat Serum. No reaction was observed
against anti-Rabbit IgG F(c), Goat IgG F(c) or anti-Pepsin.

Application Note:	This product is designed for immunofluorescence microscopy, fluorescence based plate assays (FLISA) and fluorescent western blotting. This product is also suitable for multiplex analysis, including multicolor imaging, utilizing various commercial platforms.

Shipping Condition:	Ambient
Storage Condition:	Store vial at 4° C prior to restoration. For extended storage aliquot contents and freeze at -20° C or below. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use.
Expiration:	Expiration date is one (1) year from date of receipt.
