**Background:** F(ab')2 Anti-Horse IgG Fluorescein Antibody was generated by enzymatic cleavage and

subsequent separation from the Fc fragment. Because of their smaller size, F(ab)2 fragments offer several advantages over intact antibodies for use in certain immunochemical techniques and experimental applications. F(ab)2 fragments penetrate tissue samples and show better antigen recognition and signal generation in IHC. F(ab)2 fragments lack the Fc region and therefore do not bind Fc receptors which effectively lowers background staining. F(ab')2

**Purity/Specificity:** This product is a F(ab')2 fragment of an IgG fraction antibody purified from monospecific

antiserum by a multi-step process which includes delipidation, salt fractionation, ion exchange chromatography and pepsin digestion followed by extensive dialysis against the buffer stated above. Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Peroxidase, anti-Rabbit Serum, Horse IgG and Horse Serum. No reaction was observed against

anti-Rabbit IgG F(c) or anti-Pepsin.
