Background:	Secreted as part of the adaptive immune response by plasma B cells, immunoglobulin G constitutes 75% of serum immunoglobulins. Immunoglobulin G binds to viruses, bacteria, as well as fungi and facilitates their destruction or neutralization via agglutination (and thereby immobilizing them), activation of the compliment cascade, and opsonization for phagocytosis. This product possesses the F(ab) region possessing the epitope-recognition site, both heavy and light chains of the antibody molecule are present.


Shipping Condition:	Wet Ice
Storage Condition:	Store vial at 4° C before opening. DO NOT FREEZE. This product is stable at 4° C as an undiluted liquid. Dilute only prior to immediate use. Freezing alkaline phosphatase conjugates will result in a substantial loss of enzymatic activity.
Expiration:	Expiration date is one (1) year from date of receipt.

ELISA Results of Rabbit Anti-Bovine IgG Antibody Alkaline Phosphatase Conjugated tested against purified Bovine IgG Alk Phos. Each well was coated in duplicate with 1.0 μ g of Bovine IgG (p/n 001-0102). The working dilution is 1:60,000. The starting dilution of antibody was 5μ g/ml and the X-axis represents the Log10 of a 3-fold dilution. This titration is a 4-parameter curve fit where the IC50 is defined as the titer of the antibody. Assay performed using HRP Conjugation Stabilizer (p/n MB-076) and TMB substrate (p/n TMBE-1000).
