Background: Anti-Chicken IgG Antibody generated in goat detects chicken IgY. Secreted as part of the

adaptive immune response by plasma B cells, immunoglobulin G constitutes 75% of serum immunoglobulins. Immunoglobulin G binds to viruses, bacteria, as well as fungi and facilitates their destruction or neutralization via agglutination (and thereby immobilizing them), activation of the compliment cascade, and opsonization for phagocytosis. The whole IgG molecule possesses both the F(c) region, recognized by high-affinity Fc receptor proteins, as well as the F (ab) region possessing the epitope-recognition site. Both heavy and light chains of the antibody

molecule are present.


Shipping Condition:	Wet Ice
Storage Condition:	Store vial at 4° C prior to opening. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use. For extended storage aliquot contents and freeze at -20° C or below. Avoid cycles of freezing and thawing.
Expiration:	Expiration date is one (1) year from date of receipt.

ELISA

ELISA Results of Goat Anti-Chicken IgG/IgY Antibody tested against purified Chicken IgG/IgY. Each well was coated in duplicate with 1.0 μ g of Chicken IgG/IgY (p/n 003-0102). The working dilution is 1:47,000. The starting dilution of antibody was 5μ g/ml and the X-axis represents the Log10 of a 3-fold dilution. This titration is a 4-parameter curve fit where the IC50 is defined as the titer of the antibody. Assay performed using HRP Conjugated Stabilizer (p/n MB-076), Donkey Anti-Goat IgG mx10 HRP conjugated (p/n 605-703-125), and TMB substrate (p/n TMBE-1000).
