Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Fluorescein, anti-Mouse Serum, Goat IgG and Goat Serum. No reaction was observed against Rabbit, Human and Mouse Serum Proteins.


**Storage Condition:** Store vial at 4° C prior to restoration. For extended storage aliquot contents and freeze at -20°
