Receptors bind the Fc portion of human IgG and often this fragment is removed from immunoglobulins to minimize receptor binding and lower background reactivity. Secondary Antibodies are available in a variety of formats and conjugate types. When choosing a secondary antibody product, consideration must be given to species and immunoglobulin specificity, conjugate type, fragment and chain specificity, level of cross-reactivity, and host-species source and fragment composition. 
**Storage Condition:** Store vial at 4° C prior to restoration. For extended storage aliquot contents and freeze at -20°

C or below. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an

undiluted liquid. Dilute only prior to immediate use.

**Expiration:** Expiration date is one (1) year from date of receipt.

#### **ELISA**

ELISA Results of purified Goat Anti-Human IgG F(c) Antibody Peroxidase Conjugated tested against purified Human IgG F (c) HRP. Each well was coated in duplicate with 1.0  $\mu$ g of Human IgG F(c) (p/n 009-0103) [Blue Line] and Human IgG (p/n 009-0102) [Purple Line]. The working dilution is 1:33,000. The starting dilution of antibody was  $5\mu$ g/ml and the X-axis represents the Log10 of a 3-fold dilution. This titration is a 4-parameter curve fit where the IC50 is defined as the titer of the antibody. Assay performed using TMB substrate (p/n TMBE-1000).
