Background:	Anti-Human IgG (H&L) Biotin generated in goat detects human Immunoglobulin G (IgG), both

heavy and light chains of the antibody molecule are present. It is a protein complex composed of four peptide chains — two identical heavy chains and two identical light chains arranged in a Y-shape typical of antibody monomers. Each IgG has two antigen binding sites. Representing approximately 75% of serum immunoglobulins in humans, IgG is the most abundant antibody isotype found in the circulation. IgG molecules are synthesized and secreted by plasma B cells. Secondary Antibodies are available in a variety of formats and conjugate types. When choosing a secondary antibody product, consideration must be given to species and immunoglobulin specificity, conjugate type, fragment and chain specificity, level of cross-reactivity, and host-species source and fragment composition.

A working dilution of 1:100,000 to 1:400,000 of the reconstitution concentration is suggested for this product.


Storage Condition: Store vial at 4° C prior to restoration. For extended storage aliquot contents and freeze at -20°

C or below. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an

undiluted liquid. Dilute only prior to immediate use.

Expiration: Expiration date is one (1) year from date of receipt.

ELISA

ELISA results of purified Goat Anti-Human IgG Biotin Conjugated Antibody tested against purified human IgG. Each well was coated in duplicate with 1.0 μ g of human IgG (purple line). The starting dilution of antibody was 5μ g/ml and the X-axis represents the Log10 of a 3-fold dilution. This titration is a 4-parameter curve fit where the IC50 is defined as the titer of the antibody. Assay performed using Blocking buffer MB-060-1000, Streptavidin HRP conjugate 1:10,000, and TMB-8000 substrate.
