> proteolytic fragment of immunoglobulin G (IgG) obtained by limited digestion with the enzyme papain under controlled conditions of temperature, time and pH. Receptors bind the Fc portion of human IgG and often this fragment is removed from immunoglobulins to minimize receptor binding and lower background reactivity. Secondary Antibodies are available in a variety of formats and conjugate types. When choosing a secondary antibody product, consideration must be given to species and immunoglobulin specificity, conjugate type, fragment and chain specificity, level of cross-reactivity, and host-species source and fragment composition. F(c)

Antibody is ideal for investigators who routinely perform flow cytometry,

immunohistochemistry or IHC and other immunoassays.

Storage Condition: Store vial at 4° C prior to restoration. For extended storage aliquot contents and freeze at -20°



ELISA

ELISA results of purified Rabbit anti-Human IgG F(c) Antibody Peroxidase Conjugated tested against purified Human IgG F (c). Each well was coated in duplicate with 1.0 μ g of Human IgG F(c) (p/n 009-0103). The starting dilution of antibody was 5 μ g/ml and the X-axis represents the Log10 of a 3-fold dilution. This titration is a 4-parameter curve fit where the IC50 is defined as the titer of the antibody. Assay performed using 3% fish gelatin as blocking buffer and TMB substrate p/n TMBE-1000.
