Background:	Anti-Human IgM Fc5 μ Alkaline Phosphatase antibody generated in rabbit specifically detects Fc5 μ portion of the human IgM heavy chain. Immunoglobulin M is the largest antibody isotype and the first to be secreted against an initial exposure to antigen. IgM is predominantly produced in the spleen. Formed from covalently linking 5 immunoglobulins together. Due to this large size, IgM is typically isolated to the serum. Anti-Human IgM Fc5 μ antibody is ideal for investigators in Immunology, Microbiology, and Cell Biology.

Purity/Specificity:

This product was prepared from monospecific antiserum by immunoaffinity chromatography using Human IgM coupled to agarose beads followed by solid phase adsorption(s) to remove any unwanted reactivities. Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Alkaline Phosphatase (calf intestine), anti-Rabbit Serum, Human IgM and Human Serum. Specificity was confirmed by ELISA minimal cross reactivity against other human heavy or light chain isotypes.

Application Note:	Anti-Human IgM Fc5µ Alkaline Phosphatase conjugate has been tested by dot blot and ELISA and is suitable for immunoblotting (western or dot blot), ELISA, immunoelectron microscopy and immunohistochemistry as well as other antibody-based enzymatic assays requiring lot-to-lot consistency.


Shipping Condition:	Wet Ice
Storage Condition:	Store vial at 4° C before opening. DO NOT FREEZE. This product is stable at 4° C as an undiluted liquid. Dilute only prior to immediate use. Freezing alkaline phosphatase conjugates will result in a substantial loss of enzymatic activity.
Expiration:	Expiration date is one (1) year from date of receipt.

ELISA Results of Purified Rabbit Anti-Human IgM Fc5 μ Alkaline Phosphatase Conjugated Antibody tested against purified Human IgM Fc5 μ protein. Each well was coated in duplicate with 1.0 μ g of Human IgM Fc5 μ (p/n 009-0131). The starting dilution of antibody was 5 μ g/ml and the X-axis represents the Log10 of a 3-fold dilution. This titration is a 4-parameter curve fit where the IC50 is defined as the titer of the antibody. Assay performed using NPP Substrate (p/n NPP-100).
