
Shipping Condition:	Wet Ice

ELISA

ELISA results of purified Sheep anti-Mouse IgG tested against purified Mouse IgG. Each well was coated in duplicate with 1.0 μ g of Mouse IgG (p/n 010-0102). The starting dilution of antibody was 5μ g/ml and the X-axis represents the Log10 of a 3-fold dilution. This titration is a 4-parameter curve fit where the IC50 is defined as the titer of the antibody. Assay performed using Blocking buffer (p/n MB-060-1000), Dky-anti-Sheep HRP conjugate (p/n 613-7302), and TMB substrate (p/n TMBE-1000).
