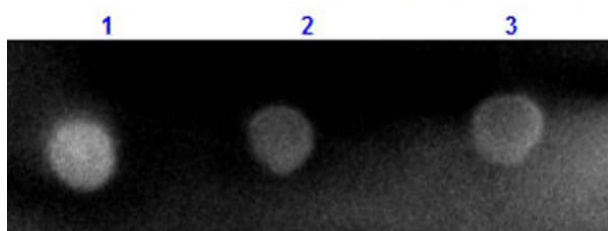

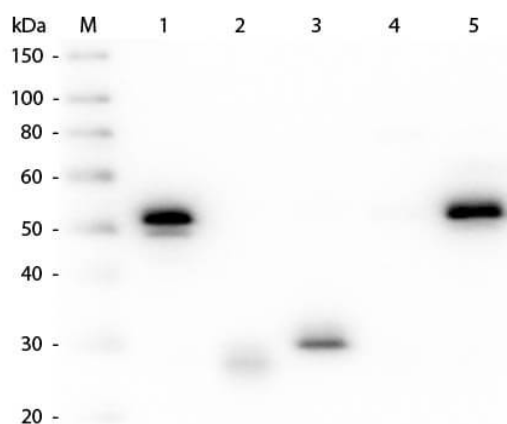

Dot Blot results of Mouse Anti-Rabbit IgG Antibody Rhodamine Conjugated. Dots are Rabbit IgG at (1) 100ng, (2) 33.3ng, (3) 11.1ng, (4) 3.70ng, (5) 1.23ng. Blocking: MB-070 for 60 min at RT. Primary Antibody: none. Secondary Antibody: Mouse Anti-Rabbit IgG TRITC at 1µg/mL for 1hr at RT. Imaged with BioRad ChemiDoc, Rhodamine filter.
