
Shipping & Handling

Storage Condition:	Store vial at 4° C prior to opening. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use. For extended storage aliquot contents and freeze at -20° C or below. Avoid cycles of freezing and thawing.
Expiration:	Expiration date is one (1) year from date of receipt.

ELISA

ELISA results of purified ELISA of Donkey anti-Sheep IgG Antibody tested against purified Sheep IgG. Each well was coated in duplicate with 1.0 μ g of Sheep IgG. The starting dilution of antibody was 5 μ g/ml and the X-axis represents the Log10 of a 3-fold dilution. This titration is a 4-parameter curve fit where the IC50 is defined as the titer of the antibody. Assay performed using Blocking buffer MB-060-1000, Gt-a-Donkey IgG HRP conjugate 1:10,000, and TMB-8000 substrate.
