Product Details

Background:	Anti-Swine IgG F(c) generated in rabbit is a proteolytic fragment of immunoglobulin G (IgG) obtained by limited digestion with the enzyme papain under controlled conditions of temperature, time and pH. Receptors bind the Fc portion of swine IgG and often this fragment is removed from immunoglobulins to minimize receptor binding and lower background reactivity.

Purity/Specificity: This product was prepared from monospecific antiserum by immunoaffinity chromatography

using Swine IgG coupled to agarose beads. Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Peroxidase, anti-Rabbit Serum, Swine IgG, Swine IgG F(c) and Swine

Serum. No reaction was observed against Swine IgG F(ab).

Preservative:	0.01% (w/v) Gentamicin Sulfate. Do NOT add Sodium Azide!
Stabilizer:	10 mg/mL Bovine Serum Albumin (BSA) - Immunoglobulin and Protease free
Reconstitution Volume:	1.0 mL
Reconstitution Buffer:	Restore with deionized water (or equivalent)

Shipping & Handling

Shipping Condition:	Ambient
Storage Condition:	Store vial at 4° C prior to restoration. For extended storage aliquot contents and freeze at -20° C or below. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use.



ELISA Results of Rabbit Anti-Swine IgG F(c) Antibody Peroxidase Conjugated tested against purified Swine IgG F(c) HRP. Each well was coated in duplicate with 1.0 μg of Swine IgG F(c) (p/n 014-0104) [Red Line] and Swine IgG (p/n 014-0102) [Green Line]. The working dilution of Swine IgG F(c) is 1:219,000. The starting dilution of antibody was 5 $\mu g/ml$ and the X-axis represents the Log10 of a 3-fold dilution. This titration is a 4-parameter curve fit where the IC50 is defined as the titer of the antibody. Assay performed using HRP Conjugate Stabilizer (p/n MB-076) and TMB substrate (p/n TMBE-1000).
