Background:	Anti-Donkey IgG Peroxidase Antibody generated in goat detects donkey IgG. Secreted as part of the adaptive immune response by plasma B cells, immunoglobulin G constitutes 75% of serum immunoglobulins. Immunoglobulin G binds to viruses, bacteria, as well as fungi and facilitates their destruction or neutralization via agglutination (and thereby immobilizing them), activation of the compliment cascade, and opsonization for phagocytosis. The whole IgG molecule possesses both the F(c) region, recognized by high-affinity Fc receptor proteins, as well as the F (ab) region possessing the epitope-recognition site. Both heavy and light chains of the antibody molecule are present.

unwanted reactivities. Assay by immunoelectrophoresis resulted in a single precipitin arc
against anti-Peroxidase, anti-Goat Serum, Donkey IgG and Donkey Serum.

Reconstitution Buffer:	Restore with deionized water (or equivalent)

Shipping Condition:	Ambient
Storage Condition:	Store vial at 4° C prior to restoration. For extended storage aliquot contents and freeze at -20° C or below. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use.





ELISA Results of Goat Anti-Donkey IgG Antibody Peroxidase Conjugate tested against purified Donkey IgG HRP. Each well was coated in duplicate with 1.0 μ g of Donkey IgG (p/n 016-0102). The working dilution is 1:188,000. The starting dilution of antibody was 5 μ g/ml and the X-axis represents the Log10 of a 3-fold dilution. This titration is a 4-parameter curve fit where the IC50 is defined as the titer of the antibody. Assay performed using HRP Conjugate Stabilizer (p/n MB-076) and TMB substrate (p/n TMBE-1000).
