Background:	Anti-Monkey IgM (mu chain) Texas Red conjugated antibody generated in goat specifically detects monkey IgM. Immunoglobulin M is the largest antibody isotype and the first to be secreted against an initial exposure to antigen. IgM is predominantly produced in the spleen. Formed from covalently linking 5 immunoglobulins together, the approximate molecular weight of IgM is 900kDa and possesses 10 binding sites (though due to the size of most antigens, not all sites are capable of binding at once). Due to this large size, IgM is typically isolated to the serum. Anti-Monkey IgM antibody is ideal for investigators in Immunology, Microbiology, and Cell Biology.

using Monkey antigens coupled to agarose beads followed by solid phase adsorption(s) to
remove any unwanted reactivities. Assay by immunoelectrophoresis resulted in a single
precipitin arc against anti-Goat Serum, Monkey IgM and Monkey Serum. No reaction was
observed against other monkey heavy or light chain proteins.
