Background:	F(ab') ₂ Anti-Goat IgG Texas Red Antibody was generated by enzymatic cleavage and subsequent separation from the Fc fragment. Because of their smaller size, F(ab') ₂ fragments offer several advantages over intact antibodies for use in certain immunochemical techniques and experimental applications. F(ab') ₂ fragments penetrate tissue samples and show better antigen recognition and signal generation in IHC. F(ab') ₂ fragments lack the Fc region and therefore do not bind Fc receptors which effectively lowers background staining. F(ab') ₂ Antibody is ideal for investigators who routinely perform flow cytometry, immunohistochemistry or IHC and other immunoassays.

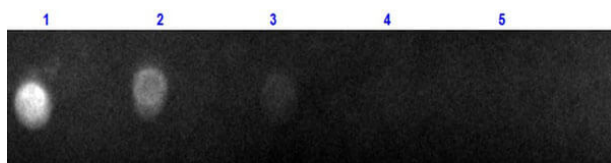

Storage Condition:	Store vial at 4° C prior to restoration. For extended storage aliquot contents and freeze at -20° C or below. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use.
Expiration:	Expiration date is one (1) year from date of receipt.

Secondary Antibody: F(ab)₂ Rabbit Anti-Goat IgG (H&L) Antibody Texas Red™ Conj'd at 1mg/mL at RT for 1 hour. Block: MB-070 at RT for 30 minutes.
