| Background: | F(ab') ₂ Anti-Guinea Pig IgG Peroxidase Antibody was generated by enzymatic cleavage and subsequent separation from the Fc fragment. Because of their smaller size, F(ab') ₂ fragments offer several advantages over intact antibodies for use in certain immunochemical techniques and experimental applications. F(ab') ₂ fragments penetrate tissue samples and show better antigen recognition and signal generation in IHC. F(ab') ₂ fragments lack the Fc region and therefore do not bind Fc receptors which effectively lowers background staining. F(ab') ₂ Antibody is ideal for investigators who routinely perform flow cytometry, immunohistochemistry or IHC and other immunoassays. |

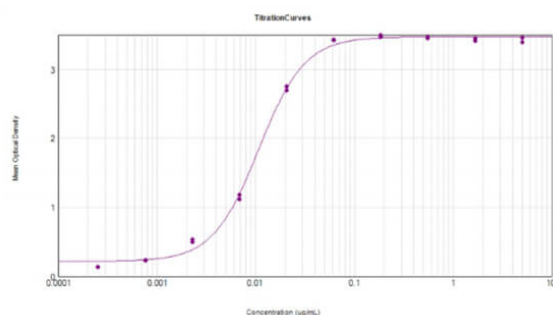

Storage Condition: Store vial at 4° C prior to restoration. For extended storage aliquot contents and freeze at -20° C or below. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use.

Expiration: Expiration date is one (1) year from date of receipt.

ELISA Results of F(ab')₂ Goat Anti-Guinea Pig IgG Antibody Peroxidase Conjugated. Each well was coated in duplicate with 1.0 µg of Guinea Pig IgG (p/n 006-0102). The working dilution is 93,100. The starting dilution of antibody was 5µg/ml and the X-axis represents the Log₁₀ of a 3-fold dilution. This titration is a 4-parameter curve fit where the IC₅₀ is defined as the titer of the antibody. Assay performed using 3% Fish Gel/PBS (p/n MB-066) and TMB substrate (p/n TMBE-1000).
