## **Product Details**

Background:	F(ab')2 Anti-Mouse IgG (H&L) Alkaline Phosphatase Antibody generated in goat was generated by enzymatic cleavage and subsequent separation from the Fc fragment. Because of their smaller size, F(ab)2 fragments offer several advantages over intact antibodies for use in certain immunochemical techniques and experimental applications. F(ab)2 fragments penetrate tissue samples and show better antigen recognition and signal generation in IHC. F(ab)2 fragments lack the Fc region and therefore do not bind Fc receptors which effectively lowers background staining. F(ab')2 Antibody is ideal for investigators who routinely perform flow cytometry, immunohistochemistry or IHC and other immunoassays.

A working dilution of 1:4,000 to 1:20,000 of the reconstitution concentration is suggested for this product.

ELISA Results of Goat F(ab')2 Anti-Mouse IgG Antibody Alkaline Phosphatase Min X Bv Hs Hu Rb Rt Sh Serum Proteins. Each well was coated in duplicate with 10  $\mu$ g of Mouse IgG (p/n 010-0102). The starting dilution of antibody was 5 $\mu$ g/ml and the X-axis represents the Log10 of a 3-fold dilution. This titration is a 4-parameter curve fit where the IC50 is defined as the titer of the antibody. Assay performed using 3% Fish Gel/PBS Buffer (p/n MB-066) and TMB substrate (p/n TMBE-1000).
