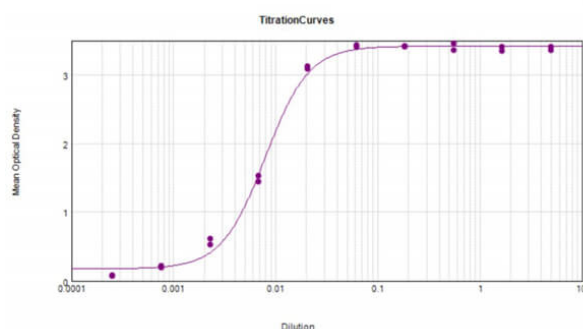

**Storage Condition:** Store vial at 4° C prior to restoration. For extended storage aliquot contents and freeze at -20° C or below. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use.

**Expiration:** Expiration date is one (1) year from date of receipt.

## ELISA

ELISA Results of Goat F(ab')<sub>2</sub> Anti-Mouse IgG Antibody Biotin Min X Bv Hs Hu Rb Rt Sh Serum Proteins. Each well was coated in duplicate with 1.0 µg of Mouse IgG (p/n 010-0102). The working dilution is 127,000. The starting dilution of antibody was 5µg/ml and the X-axis represents the Log<sub>10</sub> of a 3-fold dilution. This titration is a 4-parameter curve fit where the IC<sub>50</sub> is defined as the titer of the antibody. Assay performed using Donkey Anti-Goat IgG HRP conjugated and TMB substrate p/n TMBE-1000.
