Background:	F(ab') ₂ Anti-Mouse IgG (H&L) Peroxidase Antibody generated in rabbit was generated by enzymatic cleavage and subsequent separation from the Fc fragment. Because of their smaller size, F(ab') ₂ fragments offer several advantages over intact antibodies for use in certain immunochemical techniques and experimental applications. F(ab') ₂ fragments penetrate tissue samples and show better antigen recognition and signal generation in IHC. F(ab') ₂ fragments lack the Fc region and therefore do not bind Fc receptors which effectively lowers background staining. F(ab') ₂ Antibody is ideal for investigators who routinely perform flow cytometry, immunohistochemistry or IHC and other immunoassays. F(ab') ₂ Anti-Mouse IgG antibody is ideal for investigators involved in serum component protein research.

Purity/Specificity:	F(ab') ₂ Anti-Mouse IgG (H&L) was prepared from monospecific antiserum by immunoaffinity chromatography using Mouse IgG coupled to agarose beads followed by solid phase adsorption (s) to remove any unwanted reactivities, pepsin digestion and chromatographic separation. Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Peroxidase, anti-Rabbit Serum, Mouse IgG and Mouse Serum. No reaction was observed against anti-Pepsin, anti-Rabbit IgG F(c) or Human Serum Proteins.

Application Note:	F(ab') ₂ Anti-Mouse IgG Peroxidase Conjugated Antibody has been tested by ELISA and is assayed against 1.0 ug of Mouse IgG in a standard capture ELISA using ABTS (2,2'-azino-bis-[3-ethylbenthiazoline-6-sulfonic acid]) as a substrate for 30 minutes at room temperature. A working dilution of 1:2,000 to 1:20,000 of the reconstitution concentration is suggested for this product. Specific conditions for reactivity should be optimized by the end user.
Assay Dilutions:	All assays should be optimized by the user. Recommended dilutions (if any) may be listed below.

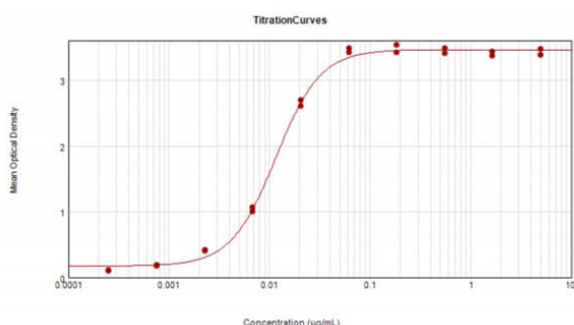

Shipping Condition:	Ambient

Storage Condition: Store vial at 4° C prior to restoration. For extended storage aliquot contents and freeze at -20° C or below. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use.

Expiration: Expiration date is one (1) year from date of receipt.

ELISA Results of Rabbit F(ab')₂ Anti-Mouse IgG Antibody Peroxidase Conjugated Min X human serum protein. Each well was coated in duplicate with 10 µg of Mouse IgG (p/n 010-0102). The working dilution is 87100. The starting dilution of antibody was 5µg/ml and the X-axis represents the Log₁₀ of a 3-fold dilution. This titration is a 4-parameter curve fit where the IC₅₀ is defined as the titer of the antibody. Assay performed using 3% Fish Gel/PBS (p/n MB-066), TMB substrate (p/n TMBE-1000).
