using Rabbit IgG coupled to agarose beads followed by solid phase adsorption(s) to remove any

unwanted reactivities, pepsin digestion and chromatographic separation. Assay by

immunoelectrophoresis resulted in a single precipitin arc against anti-Goat Serum, Rabbit IgG, Rabbit IgG F(c), and Rabbit Serum. No reaction was observed against anti-Pepsin, anti-Goat IgG

F(c), or Rabbit IgG F(ab).
