Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Peroxidase, anti-Goat Serum, Rabbit IgG, Rabbit IgG F(c) and Rabbit Serum. No reaction was observed against anti-Pepsin, anti-Goat IgG F(c) or Rabbit IgG F(ab).

## Application Details

<b>Application Note:</b>	This product has been assayed against 1.0 ug of Rabbit IgG in a standard capture ELISA using ABTS (2,2'-azino-bis-[3-ethylbenthiazoline-6-sulfonic acid]) code # ABTS-100 as a substrate for 30 minutes at room temperature. A working dilution of 1:1,000 to 1:5,000 of the reconstitution concentration is suggested for this product.
<b>Assay Dilutions:</b>	All assays should be optimized by the user. Recommended dilutions (if any) may be listed below.
<b>ELISA:</b>	1:10,000 - 1:50,000
<b>IHC:</b>	1:500 - 1:2,500

<b>Stabilizer:</b>	10 mg/mL Bovine Serum Albumin (BSA) - Immunoglobulin and Protease free
<b>Reconstitution Volume:</b>	500 µL
<b>Reconstitution Buffer:</b>	Restore with deionized water (or equivalent)

## Shipping & Handling

<b>Shipping Condition:</b>	Ambient
<b>Storage Condition:</b>	Store vial at 4° C prior to restoration. For extended storage aliquot contents and freeze at -20° C or below. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use.

**Expiration:** Expiration date is one (1) year from date of receipt.
