using Rat IgG coupled to agarose beads followed by solid phase adsorption(s) to remove any

unwanted reactivities, pepsin digestion and chromatographic separation. Assay by

immunoelectrophoresis resulted in a single precipitin arc against anti-Goat Serum, Rat IgG, Rat IgG F(c) and Rat Serum. No reaction was observed against anti-Pepsin, anti-Goat IgG F(c), Rat

IgG F(ab) or Bovine, Horse and Human Serum Proteins.

C or below. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an

undiluted liquid. Dilute only prior to immediate use.

Expiration: Expiration date is one (1) year from date of receipt.
