unwanted reactivities, pepsin digestion and chromatographic separation. Assay by

immunoelectrophoresis resulted in a single precipitin arc against anti-Fluorescein, anti-Rabbit Serum, Rat IgG and Rat Serum. No reaction was observed against anti-Pepsin or anti-Rabbit IgG
