using Rat IgG coupled to agarose beads followed by solid phase adsorption(s) to remove any

unwanted reactivities, pepsin digestion and chromatographic separation. Assay by

immunoelectrophoresis resulted in a single precipitin arc against anti-Peroxidase, anti-Rabbit Serum, Rat IgG and Rat Serum. No reaction was observed against anti-Pepsin or anti-Rabbit IgG

undiluted liquid. Dilute only prior to immediate use.
