using Swine IgG coupled to agarose beads followed by solid phase adsorption(s) to remove any unwanted reactivities, pepsin digestion and chromatographic separation. Assay by

immunoelectrophoresis resulted in a single precipitin arc against anti-Rabbit Serum, Swine IgG and Swine Serum. No reaction was observed against anti-Pepsin or anti-Rabbit IgG F(c).

C or below. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use.

**Expiration:** Expiration date is one (1) year from date of receipt.
