unwanted reactivities, papain digestion and chromatographic separation. Assay by
immunoelectrophoresis resulted in a single precipitin arc against anti-Fluorescein and anti-
Donkey Serum. No reaction was observed against anti-Papain or anti-Donkey IgG F(c).
