**Purity/Specificity:** Fab Anti-Goat IgG (H&L) was prepared from monospecific antiserum by immunoaffinity

chromatography using Goat IgG coupled to agarose beads followed by solid phase adsorption(s) to remove any unwanted reactivities, papain digestion and chromatographic separation. Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Biotin and anti-Donkey

Serum. No reaction was observed against anti-Papain or anti-Donkey IgG F(c).


Storage Condition: Store vial at 4° C prior to restoration. For extended storage aliquot contents and freeze at -20°

C or below. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an

undiluted liquid. Dilute only prior to immediate use.

**Expiration:** Expiration date is one (1) year from date of receipt.

#### **ELISA**

ELISA results of purified Donkey Fab Anti-Goat IgG Antibody Biotin Conjugated tested against purified Goat IgG. Each well was coated in duplicate with 1.0  $\mu$ g of Goat IgG. The starting dilution of antibody was  $5\mu$ g/ml and the X-axis represents the Log10 of a 3-fold dilution. This titration is a 4-parameter curve fit where the IC50 is defined as the titer of the antibody. Assay performed using Blocking buffer (p/n MB-060-1000), Streptavidin-HRP conjugated (p/n S000-03), and TMB substrate (p/n TMBE-1000).
