Purity/Specificity:

This product was prepared from monospecific antiserum by immunoaffinity chromatography using Mouse IgG coupled to agarose beads followed by solid phase adsorption(s) to remove any unwanted reactivities, papain digestion and chromatographic separation. Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Fluorescein and anti-Goat Serum. No reaction was observed against anti-Papain or anti-Goat IgG F(c).

This product is also suitable for multiplex analysis, including multicolor imaging, utilizing various commercial platforms.

Storage Condition:	Store vial at 4° C prior to restoration. For extended storage aliquot contents and freeze at -20° C or below. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use.





Primary Antibody: Goat Anti-Mouse IgG FITC at 1 μ g/mL for 1hr at RT. Secondary Antibody: none. Imaged with BioRad ChemiDoc, FITC filter.
