# Purity/Specificity:Fab Anti-MOUSE IgG (H&L) was prepared from monospecific antiserum by immunoaffinity<br/>chromatography using Mouse IgG coupled to agarose beads followed by solid phase adsorption<br/>(s) to remove any unwanted reactivities, papain digestion and chromatographic separation.<br/>Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Peroxidase and<br/>anti-Rabbit Serum. No reaction was observed against anti-Papain or anti-Rabbit IgG F(c).

Shipping Condition:	Ambient
Storage Condition:	Store vial at 4° C prior to restoration. For extended storage aliquot contents and freeze at -20° C or below. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use.
