<b>Background:</b>	TE buffer is a commonly used buffer solution in molecular biology, especially in procedures involving DNA or RNA. Tris-EDTA buffer is derived from its components: Tris, a common pH buffer, and EDTA, a molecule that chelates cations like Mg <sup>2+</sup> . The purpose of TE buffer is to solubilize DNA or RNA, while protecting it from degradation.
